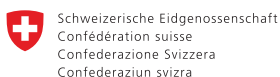

■ Damaged stalk and calyx



■ Considerable sunburn



■ Slight rotting



■ External contamination of product



■ Remains of mites



■ Bruising



■ External damage by parasites and sunburn

### EXTRA CLASS



■ Perfect product



### CLASS I



■ Slight defect in shape

■ Very small spots on the surface



■ Slight defect in shape

### CLASS II



■ Blemish due to lack of nutrition



■ Mechanical damage of the apex



■ Damage of stalk and calyx



■ Defect in shape



■ Small spots on the surface



■ Healed damage up to 2.5 cm in length

## PACKAGING

## (SOMBORKA) PRODUCT CLASSIFICATION

Brochure based on UNECE standards

- Acceptable uniformity in colour for peppers – allowed for **EXTRA CLASS**.  
The difference in diameter between peppers in the same packaging should not be greater than 20 mm in order to have uniformity in **EXTRA CLASS**.



- Acceptable presentation for **CLASS I**.  
The difference in diameter between peppers in the same packaging should not be greater than 20 mm in order to have uniformity in **CLASS I**.



- Acceptable presentation for **CLASS II**.  
Grading by size is not necessary for **CLASS II**.
